**ESTABLISHMENT OF INTERNATIONAL ARRIVAL AND DEPARTURE FEES FOR  
REGULATORY AND SAFETY OVERSIGHT FUNCTIONS**

1. **INTRODUCTION**

With effect from 01 November 2016 the Civil Aviation Authority of Thailand will collect an arrival and departure fee to support the performance of regulatory and safety oversight functions.

2. **ESTABLISHMENT OF ARRIVAL AND DEPARTURE FEE**

In order to support the performance of regulatory functions, the Civil Aviation Authority of Thailand will collect the International Arrival and Departure Fee from air operators on the basis of numbers of arriving and departing passengers international flights.

**CHARGE APPLICATION**

Air Operators shall collect and remit the International Arrival and Departure Fee by calculated from the number of arriving and departing passengers on international flights, at the rate of 15 (fifteen) Thai baht (THB) per passenger per flight including transit and transfer passengers.

The following air operators are required to collect and remit the fee:

- 1) Operators with a Thai Air Operator Certificate providing scheduled and/or non-scheduled air transport services on international routes; and
- 2) Foreign air operators providing scheduled and/or non-scheduled air transport services on international routes.

**PAYMENT**

Fees unpaid or not fully paid by the due date shall be liable for a surcharge of two percent per month.
