Purpose of a Common Aeronautical VPN (CRV)

- CRV provides a MPLS IP-based VPN communication network provided by a common network service provider in order to support all Aeronautical Fixed Service (e.g. AMHS, AIDC, ATFM, SWIM, ADS-B, voice) in the APAC region
 - A common platform to facilitate information exchange between different ANSPs in the APAC region
 - To harmonise the network infrastructure and replace legacy network which may no longer support higher bandwidth applications
- Arising from APANPIRG/24, CRV Task Force was established to identify the actions required to implement CRV and to come up with a harmonised approach for the APAC region

CRV in **ASEAN**

The ASEAN ATM Master Plan approved by 44rd STOM/23rd ATM in October 2017 identified CRV as one of the 5 priorities for harmonised implementation across ASEAN Member States

- Singapore would begin to connect to CRV using AFTN and AMHS in 2019
 - Connection to CRV for AMHS will begin with:
 - i. Australia in June 2019;
 - ii. Thailand in 2Q 2019;
 - iii. Japan in 3Q 2019; and
 - iv. India in 2019
- Thailand would connect to CRV with Hong Kong, Japan, Philippines and Singapore by 2019
