**Notification of the Civil Aviation Authority of Thailand**  
**Re.: Conditions upon Which Flight Permission for Aircraft**  
**Entering into Thailand Shall Be Granted No.2**  
**B.E. 2564 (2021)**

Reference is made to the Notifications of the Civil Aviation Authority of Thailand Re.: Conditions upon Which Flight Permission for Aircraft Entering into Thailand Shall Be Granted B.E. 2564 (2021), notified on 31 March B.E. 2564 (2021) prescribing conditions for permitting aircraft to enter into the Kingdom of Thailand from foreign countries.

In order to provide a guideline for those involved and ensure consistency with the regulation issued under section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 26) issued on 29 June B.E. 2564 (2021) and Order of the Centre for COVID-19 Situation Administration No. 7/2564 Re : Guidelines Based on Regulations Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 11) issued on 29 June B.E. 2564 (2021), by virtue of Section 27 and 28 of the Air Navigation Act B.E. 2497, the Director General of the Civil Aviation Authority of Thailand hereby issues the notification as follows:

Clause 1 The following clause shall be added as (12) in Clause 4 of the Notification of the Civil Aviation Authority of Thailand Re.: Conditions upon Which Flight Permission for Aircraft Entering into Thailand Shall Be Granted B.E. 2564 (2021), notified on 31 March B.E. 2564 (2021):

“(12) Those permitted to enter into Thailand in such areas designated as tourism pilot provinces for benefits of economics, tourism, or other activities in accordance with Thai government's policy”

Clause 2 The person who enters into the Kingdom under Clause 1 shall be under control and supervision of the competent official or the communicable disease control officer and shall also comply with disease prevention measures for travelers entering into the Kingdom specified in Clause 2 of the regulation issued under section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 26) issued on 29 June B.E. 2564 (2021) and shall comply with Disease Prevention Measures for the Persons Entering the Kingdom to Prevent the Spread of the COVID-19 Disease Attached to the Order of the Centre for COVID-19 Situation Administration

No. 7/2564, Re: Guidelines Based on Regulations Issued under Section 9 of the Emergency Decree on Public Administration in Emergency Situations B.E. 2548 (2005) (No. 11) issued on 29 June B.E. 2564 (2021).

This notification shall be effective from 1 July B.E. 2564 (2021) onwards.
