# **Airworthiness Directive**

Note: This Airworthiness Directive (AD) is issued by EASA, acting in accordance with Regulation (EU) 2018/1139 on behalf of the European Union, its Member States and of the European third countries that participate in the activities of EASA under Article 129 of that Regulation.

This AD is issued in accordance with Regulation (EU) 748/2012, Part 21.A.3B. In accordance with Regulation (EU) 1321/2014 Annex I Part M.A.301, or Annex Vb Part M.A.301, as applicable, the continuing airworthiness of an aircraft shall be ensured by accomplishing any applicable ADs. Consequently, no person may operate an aircraft to which an AD applies, except in accordance with the requirements of that AD, unless otherwise specified by the Agency [Regulation (EU) 1321/2014 Annex I Part M.A.303, or Annex Vb Part M.A.303, as applicable] or agreed with the Authority of the State of Registry [Regulation (EU) 2018/1139, Article 71 exemption].

### **Definitions:**

For the purpose of this AD, the following definitions apply:

**The Variation**: Airbus A318/A319/A320/A321 Airworthiness Limitations Section (ALS) Part 2 Damage Tolerant Airworthiness Limitations Items (DT-ALI) Revision 09 Variation 9.3.

**The AMP**: The Aircraft Maintenance Programme (AMP) contains the tasks on the basis of which the scheduled maintenance is conducted to ensure the continuing airworthiness of each operated aeroplane. For aeroplanes operated under EU regulation the operator or the owner ensures compliance with the AMP as stipulated in Commission Regulation (EU) <u>1321/2014</u>.

**New and/or more restrictive tasks**: This includes all tasks that are new and all tasks for which a threshold or interval was reduced, which were introduced through the Variation (as defined in this AD) since the previous ALS Revision that is currently incorporated in the AMP.

#### Reason:

The airworthiness limitations for the Airbus A320 family aeroplanes, which are approved by EASA, are currently defined and published in the Airbus A318/A319/A320/A321 ALS documents. These instructions have been identified as mandatory for continued airworthiness. The tasks and airworthiness limitations with regard to damage tolerant items are specified in ALS Part 2 DT-ALI.

Failure to accomplish these instructions could result in an unsafe condition.

EASA previously issued AD 2022-0085, requiring the actions described in Airbus A318/A319/A320/A321 ALS Part 2 DT ALI Revision 09, and AD 2023-0008, requiring the actions described in Airbus A318/A319/A320/A321 ALS Part 2 DT-ALI Revision 09 Variation 9.2, to introduce new tasks and limitations, and tasks and limitations for which the threshold or interval was reduced.

Since those ADs were issued, Airbus published additionally the Variation, which contains new and/or more restrictive tasks and limitations. These tasks and limitations are expected to be incorporated into A318/A319/A320/A321 ALS Part 2 DT-ALI at the next revision.

For the reason described above, this AD requires accomplishment of the actions specified in the Variation. EASA AD 2022-0085 and AD 2023-0008 are not superseded by this AD.

### Required Action(s) and Compliance Time(s):

Required as indicated, unless accomplished previously:

#### Maintenance Tasks and Replacement of Life Limited Parts:

(1) From the effective date of this AD, within the thresholds and intervals as defined in the Variation (see Note 1 of this AD), accomplish the actions as specified in the Variation, as applicable to aeroplane model and depending on aeroplane configuration.

Where this AD requires a task which is already required per EASA AD 2022-0085 or AD 2023-0008, the instructions of the Variation invalidate the instructions of Airbus A318/A319/A320/A321 ALS Part 2 DT-ALI Revision 09 and/or A318/A319/A320/A321 ALS Part 2 DT-ALI Revision 09 Variation 9.2 for that task.

Note 1: For the purpose of this AD, the thresholds and intervals as defined in the 'Compliance Time' pages of the ALS include specific compliance times for certain tasks.

### Corrective Action(s):

(2) In case of finding discrepancies during accomplishment of any task as required by paragraph (1) of this AD, before next flight, accomplish the applicable corrective action(s) in accordance with the applicable Airbus maintenance documentation. If a detected discrepancy cannot be corrected by using existing Airbus instructions, before next flight, contact Airbus for approved instructions and accomplish those instructions accordingly.

#### AMP Revision:

(3) Within 12 months after the effective date of this AD, revise the approved AMP by incorporating the limitations, tasks and associated threshold and intervals described in the Variation, as applicable to aeroplane model and depending on aeroplane configuration.

### **Recording AD Compliance:**

(4) When the AMP of an aeroplane has been revised as required by paragraph (3) of this AD, as applicable, that action ensures continued accomplishment of the tasks as required by paragraphs (1) and (2) of this AD for that aeroplane. Consequently, after revising the AMP, as required by paragraph (3) of this AD, as applicable, it is not necessary that accomplishment of individual action is recorded for demonstration of AD compliance on a continued basis.

- 2. This AD was posted on 26 June 2023 as PAD 23-080 for consultation until 24 July 2023. No comments were received during the consultation period.

Such components may be installed under an FAA Parts Manufacturer Approval (PMA), Supplemental Type Certificate (STC) or other modification.
