ATTACHMENT: NOTICE OF AIRPORT CAPACITY (NAC) W24

VTSM – Samui Airport

- 1. Parking stand minimum break time between arriving and departing aircraft is 30 minutes.
- 2. Controlled by environmental measures with allowed maximum 50 flights per day (100 movements/day excluding GA flight).
 - 2.1. Specific quota of aircraft types in daily operation are as follows:
 - 2.1.1. A319 total 32 flights (64 movements) per day (equivalent or less than CL600, CL601, CRJ9-ER, CRG-LR, CVR580, DHC7, DHC8 and DO228).
 - 2.1.2. ATR72 total 16 flights (32 movements) per day (equivalent or less than DO328, EMB14L and SABR80).
 - 2.1.3. B737 total 2 flights (4 movements) per day (equivalent or less than BOEING737-300, BOEING737-3B2, BOEING717-200 and BOEING737-500).
 - 2.2. Specific quota at 06.00 until 07.00LT allow 1 flight (2 movements) per day
- 3. Stands number 1-11 (total 11 stands) locate at 'East apron' (stands number 1-3 and 9-11 are M.A.R.S concept), conditions as following:
 - 3.1. Maximum 2 B737/E290 and 5 A319/AT72 park simultaneously (B737/E290 parking allowed at stand number 2 and 10 only)
 - 3.2. Maximum 7 A319 park simultaneously.
 - 3.3. Maximum 9 AT72 park simultaneously.
 - 3.4. Maximum 5 A319/AT72 and 4 AT72 park simultaneously.
- 4. Stands number 12,14-16 (total 4 stands) located at 'West apron' are available for GA parking.
- 5. Flight requesting ground time more than 3 hours or overnight parking will be considered upon availability of parking stand.
- 6. Helicopter operators shall submit the General aviation clearance request (GCR) to VTSM airport operator directly via email: AirsideUSM@bangkokair.com for approval.
