Notification of the Civil Aviation Authority of Thailand
Re.: Passenger Service Charges to Be Collected
at Licensed Aerodromes Opened for Public (No. 4)
B.E. 2569 (2026)

Whereas it is appropriate to revise the rate of passenger service charge to be collected at licensed aerodromes opened for public under responsibility of the Department of Airports. On 27 May 2026, empowered by Section 60/37, paragraph 2 of the Air Navigation Act B.E. 2497 (1954), and its amendments, the Minister of Transport approved, upon advisory of the Civil Aviation Board in its Meeting No. 3/2568 held on 3 December 2025, that the Department of Airports be able to increase the rates of passenger service charge due to development of Common Use Passenger Processing Systems: CUPPS to be collected from passengers at Trang Airport. The passenger service charges for each international departure flight shall be not over 425 Thai baht per passenger, and for domestic departure flight, the rate shall be not over 75 Thai baht per passenger. In order to publicize and update the currently approved rate of passenger service charge to be collected from passengers at licensed aerodromes under responsibility of the Department of Airports, the Director General of the Civil Aviation Authority of Thailand hereby issues the Notification as follows:

Article 1 This Notification shall be cited as the “Notification of the Civil Aviation Authority of Thailand, Re.: Passenger Service Charges to Be Collected at Licensed Aerodromes Opened for Public (No. 4) B.E. 2569 (2026).”

Article 2 The provision in (d) of (1) of Article 2 of the Notification of the Civil Aviation Authority of Thailand, Re.: Passenger Service Charges to Be Collected at Licensed Aerodromes Opened for Public B.E. 2567 (2024), as amended by the Notification of the Civil Aviation Authority of Thailand, Re.: Passenger Service Charges to Be Collected at Licensed Aerodromes Opened for Public (No. 2) B.E. 2569 (2026) shall be repealed and replaced by the following:

“(d) Krabi Airport, Surat Thani Airport,
Ubon Ratchathani Airport, Khon Kaen Airport,
Nakhon Si Thammarat Airport,
Phitsanulok Airport, and Trang Airport: not over 425.- Thai baht;”

Article 3 The provision in (d) of (2) of Article 2 of the Notification of the Civil Aviation Authority of Thailand, Re.: Passenger Service Charges to Be Collected at Licensed Aerodromes Opened for Public B.E. 2567 (2024), as amended by the Notification of the Civil Aviation Authority of Thailand, Re.: Passenger Service Charges to Be Collected at Licensed Aerodromes Opened for Public (No. 2) B.E. 2569 (2026) shall be repealed and replaced by the following:

“(d) Krabi Airport, Surat Thani Airport,
Ubon Ratchathani Airport, Khon Kaen Airport,
Nakhon Si Thammarat Airport,
Phitsanulok Airport, and Trang Airport: not over 75.- Thai baht;”
